Ancestral and original FRRf<sup>©™</sup> issuer and registrar of good Allodial Title for the Corpus (physical body) under the law of the land, including but NOT limited to its branches: FRRf<sup>©™</sup> as Sovereign Intergovernmental Organization and the Eagle-Eye Ministries<sup>©™</sup>. We embrace applicable international law whilst working towards official and international promulgation with respect to all States and their communities that currently compose the coexistence of the peoples found on this Earth, as well as other Intergovernmental Organizations and Supreme National Unions.

## FRRf' s background:



The common Law Pure Trust ("cLPT") originated just after the middle-ages in the 12<sup>th</sup> century with King Henry II Plantagenet. Before this time, The Catholic Church had control of most land and assets. Once Henry finagled some away, he established the cLPT with his new partner Lord Bauer, the progenitor of the present-day Bauer-Rothschild family, the richest of the twelve (+1) polity or rich bank trading families. The cLPT provisions (the written rules [*principia*] of the trust) have had one hundred and four (104) revisions. The last three have been revised by a former Bauer-Rothschild attorney, Baron von Brauchitsch Bauer-Rothschild a.k.a. Sri Dr. Grantham Taylor Hughes, The Bauer foundation, copyright from 1140. The Rev. CIV is the one available with FRRf.

King Henry and Lord Bauer made the first **fidelity ceremony** as explained in Art. I of Rev. CIV provisions in circa 12<sup>th</sup> century providing the cLPT creation and execution. The concept of the cLPT has been intact since that time.

FRRf©™ was conceived under this context and was established on the 12<sup>th</sup> December 2013 as an International Common Law Issuer of good allodial title and Registrar with its own Private Records Archive under Customary International Law of land and soil jurisdiction. This was created as of the Rev. CIV done by Bauer-Rothschild attorney, Baron von Brauchitsch Bauer-Rothschild, The Bauer foundation, copyright from 1140.

In general, a Sovereign Underwriter and under the common Law Principia (cLP) is any Exchangor/Grantor of an enacted Pure Trust foundation (PTf) such as FRRf©™ and is also holder of the annexed Pure Trust certificate (PTc), along with the Pure Trust provisions (PTp). The official seal is:

Whereas, the Certified Sovereign Underwriter of FRRf<sup>©™</sup> is one who has been contractually-authorized as being qualified by natural process to issue, including but not limited to, Sovereignty Certificates, Allodial Titles, common Law Pure Trusts and so on.

The Underwriter has the capacity to act as an Independent Proto-Notary in order to certify all documents being issued and recorded under the law of the land into the International Private Archives of First Republic Registrar foundation<sup>©™</sup>. The official seal is:



The main objective of FRRf<sup>©™</sup> is to provide an international platform for all good governments, organizations and peoples to file and record good title to their corpus (natural body), landed property, and to private conveyances. This is known as Allodial Title. Our allodial titles are issued and recorded under the law of the land, and simultaneously governed and protected, as all contracts are, by the Uniform Commercial code (UCC).

As a result of the 1930 Geneva Convention, when the international community declared bankruptcy, post this period, the UCC has been the ruling international law.

Under UCC 1 bankruptcy articles, bankrupted entities (entire et al international community and its chattels, i.e., governments, banks, businesses, non-sovereigns, etc.) have no authority to operate and/or act against an ordained and/or certified sovereign. Hence, individuals who are certified sovereigns and also in possession of allodial titles to landed property and private automobiles (conveyances), are to be recognized as having the wielding power of UCC under FRRf.

Of great importance the articles of FRRf<sup>©™</sup>, a common Law Pure Trust (cLPT), are recognized by the Sovereign International Court of Justice - Sovereign International Criminal Court.

As an Official of the Sovereign ICJ/ICC our Certified Sovereign Underwriter(s) also serve the capacity as Notaries Public. All documentation that bears any official stamps and seals by the Notary of Sovereign ICJ/ICC is accepted by all jurisdictions around the world as authenticated. The Notary's main function is to bear witness to the signatories of contracts, trusts, treaties, agreements and other official documents.

After consensus voting a Notary of the SICJ-SICC can be appointed, by contract, evidenced by a Memorandum of Agreement (MoA) with two Senior Judges of the ICJ/ICC along with two high-standing witnesses. Thus, there are five signatures on the MoA.

The following seals were assigned to FRRf©™ in 2017 when it was first appointed by the Sovereign ICJ/ICC, as their official registrar.



Ancestral and Original FRRf©™ in its capacity as Issuer and Registrar also acts as a foreign office to The Talismanic Kingdom of Atmaurium and offers support to the International Community of Sovereign Kingdoms, Nations and States.



- 10 He who comes into Sovereignty must come with clean hands.
- 11 Sovereignty delights to do justice and not by halves.
- 12 Sovereignty will take jurisdiction to avoid a multiplicity of suits.
- 13 Sovereignty follows the law.
- 14 Sovereignty will not assist a volunteer.
- 15 Where Sovereignities are equal, the law will prevail.
- 16 Between equal Sovereignities the first in order of time shall prevail.
- 17 Sovereignty will not complete an imperfect gift.
- 18 Sovereignty will not allow a statute to be used as a cloak for fraud.
- 19 Sovereignty will not allow a trust to fail for want of a trustee.
- 20 Sovereignty regards the beneficiary as the true owner of property.

means a party entitled to pursue a remedy.
